


INSTRUCTION SHEET

WIDE UNIT SHELF SYSTEM



ASSEMBLY

①—Denotes to use this hardware with METHOD #1

②—Denotes to use this hardware with METHOD #2

①—METHOD #1 - STEEL RACK STYLE INSTALLATION

- 1) Mount the ears to the rackrail using the studs and nuts. (Leave loose)
- 2) Place the shelf on the top side of the ears and secure using studs and nuts.
- 3) Level the shelf and tighten all hardware.

②—METHOD #2- WOODEN RACK STYLE INSTALLATION

- 1) Install the ears over the rackrail and secure using the Wood Screws. Level and tighten the screws.
- 2) On this installation the use of a rear support is highly recommended. An additional hole on the ear and appropriate spacers have been provided for this purpose.
- 3) Place the shelf on the top side of the ears and secure using studs and nuts.
