
## **INSTALLATION (Continued)**

4) Install the extrusion with assembled desk support bracket onto the LD Series Wedge tab and install (2) 1/4-20x5/8" allen screws as shown. (**FIGURE D**)

5) Install the LD-12 cabinet tab into the extrusion channel and secure the LD-12 to the LD series wedge using (2) #10 x 5/8" panhead screws as shown. (**FIGURE E**)
