


TOOLS NEEDED: 5/8" wrench or socket

NOTE: For use on DRK, ERK, MRK, SCRK, VRK, and WRK Series 44 space racks.


1) In desired mounting location along the rackrail brackets, align panel adapter mounting holes with fixed holes on rackrail bracket and attach using supplied hardware (FIGURE A). Align panel adapters vertically.



2) Repeat Step 1 for subsequent panel adapter.



3) To mount equipment, install supplied clip nuts in desired location on panel adapters. (FIGURE B)



4) Using 10-32 rack screws, mount equipment to panel adapters. (FIGURE C)
