

From Plasteurope, the short press report reads: Dow: Price increase for wire and cable compounds With effect from 1 October 2007, Dow Europe (Horgen/Switzerland: <u>www.dow.com</u>) is to increase prices for all grades of wire and cable compounds by EUR 50/t in Europe, India, the Middle East, and Africa.

Belden Broadcast Promotional Agreement Update!

Dave Geon at Belden advised IEWC this week that they have once again updated our Broadcast Promotional Agreement. The last revision was done back in July.

Per Nyleen Trimborn:

I will offer some history on this agreement. ASP pricing is the best distributor pricing level offered by Belden. We were only purchasing enough Broadcast product to be at the SP pricing level. We requested a Promotional Agreement several years ago from Belden in the hopes of generating more business to get us up to an ASP pricing level. Belden recently discovered that the pricing on our agreement was better than the ASP pricing that they offer to other distributors so they are now increasing our pricing to get it up to that price level on these select items. Unfortunately we have still not built up the business enough to get to the ASP pricing level on all Broadcast products so we will still have these items that will be at a better price level than the other Broadcast items. I have contacted any sales teams that have been selling a fair amount of these items to their customer and have advised them to work with their local Belden rep to set up an End User Agreement for their customer.
